Recommend to Auditors that Supervisors be reimbursed \$.56/mile, which is the current IRS rate per mile, to attend Road Inspection, Conventions and Seminars.

EXECUTIVE SESSION – An executive session was held December 29, 2020 at 10:00 via teleconference with the township's solicitor to discuss the status of a lawsuit filed against the township in December 2019. The "Acre Complaint" did not come up so will be discussed at a later date. Scott will contact Tom Oeste, township solicitor to advise him of the call we received regarding a sink-hole in Grist Mill which is in the right of way owned by the HOA. Supervisor Rugen informed the others that the Road Master had to come in Christmas Eve to clear a drain in Grist Mill. The Secretary reported that we did not hear any response from Mrs. Woodward regarding suggestions on the water at her property on Old Limestone Road.

MICHELE WASHBURN (Mikki) – Mrs. Washburn of 165 Draper Lane was present to seek advice on researching Draper Lane and the ownership of the right of way along with gathering information to bring the lane up to PENNDOT specifications. Draper Lane is a private land and is in poor condition from all the truck delivery traffic. Mrs. Washburn's husband has purchased gravel over the years to place on the lane. Supervisor Fleischmann introduced Mrs. Washburn to Chescoviews and suggested she start her research at the Recorder of Deeds office.

COVID VACCINATION PLANNING - The township received information from Chester County Health Department regarding vaccination planning. CCHD is seeking estimates of employees who would be interested in receiving the vaccine. We would fall under the guidelines of Phase 1B. A time and place have not been established as of yet.

ZONING – The Supervisors reviewed the Zoning Officer's report for the month. Mr. Beers reported that there are no new updates for Dr. Martin issue on the Ray Mar Road creek. Howard reported that the Gilberts meadow has been eaten up by water since the Martins has straightened up the creek. Bill will follow up with the person at DEP tomorrow and report back to the Supervisors. Bill stated that he will check into Premium Power regarding a trailer with their name on it. Bill also informed the Supervisors that the Solicitor is working on the "Acre Complaint".

ROADS – The Supervisors reviewed the Road Master's report for the month.
