## UPPER OXFORD TOWNSHIP APRIL 13, 2020

Upper Oxford Township Board of Supervisors held their regular monthly meeting at the Township Building, 1185 Limestone Road, Russellville, PA on Monday, April 13, 2020 at 7:00 PM.

Due to the Covid-19 virus, the agenda was posted on the front door April 9, 2020 and residents seeking to attend the meeting were instructed to call the township office to reserve a spot since seating was limited to six persons.

The meeting was called to order at 7:00 P.M. by the Chairman, Scott Rugen. After the Salute to the Flag, Scott Rugen led in prayer.

PUBLIC COMMENTS – Lieutenant Palmer was present to give the Board of Supervisors statistics reports for 2020 and compared the numbers from last year's reports. Lieutenant Palmer discussed how the Pennsylvania State Police were handling their activities during the Covid-19 virus crisis and told the Township not to hesitate to call if the State Police could help Upper Oxford Township in any way. The Supervisors thanked Lieutenant Palmer and the State Police Force for the hard work they do in keeping our communities safe.

ROADS – The Road Master's report was reviewed by the Board of Supervisors. Discussion was held on the replacement of a new diesel fuel pump assembly. Two prices were discussed. The Board will instruct the Road Master to purchase the pump for \$1550.00 and have the road crew install the pump.

HISTORIC COMMISSION - Will cancel their May meeting and not meet again until August.

PAYMENT OF BILLS – Motion was made by Charles Fleischmann, second by Howard Reyburn and carried to approve the payment of bills in the amount of \$55,654.95 from the General Fund.

AGRICULTURAL SECURITY ADDITION – A petition was received from Stewart and Wendy Ramsey, Tax Parcel #57-4-8 to add 31 acres to the present Agricultural Security Area. No action was taken on this.

C.C.A.T.O. – Supervisor Fleischmann mentioned that a Resolution was being petitioned that would allow the removal of the township's auditors and tax collector if the townships used an entity for collection for five years. One person in CCATO would like to revisit this. Supervisor Fleischmann is not in favor of this. Supervisor Rugen stated that he would not be in favor of this either.

STORM DAMAGE – Supervisor Rugen informed the others that power lines were down on Saw Mill Road last Friday and that Muddy Run, Spring Valley and Saw Mill had branches which needed to be cleaned up along with a storm drain on Saw Mill.

ROAD INSPECTION – The Road Master will be instructed to complete a road inspection and report back to the Board of Supervisors which they will then be able to review.

GRIST MILL PIPE – replacement of this pipe was discussed and the HOA's responsibility. A conference call will be scheduled with our Solicitor, Thomas Oeste. Supervisor Rugen will contact the Solicitor.

ADJOURNMENT – There being no further business, motion was made by Scott Rugen, seconded by Howard Reyburn and carried unanimously to adjourn at 8:20 P.M.
