## UPPER OXFORD TOWNSHIP JUNE 22, 2020

Upper Oxford Township Board of Supervisors held an advertised work session at the Township Building. 1185 Limestone Road, Russellville, PA on Monday, June 22, 2020 at 7:00 P.M.

MOWING – Grist Mill resident and HOA had concerns about mowing the right of way area in Grist Mill. They also had concerned regarding the property owned by Christ Church at the Grove which is rented out to a farmer. This property owned by the Church is in our Agricultural Security Area. Our roadmaster, Andy DiFilippo mowed the right-of-way on instructions of the supervisors.

NOXIOUS WEED ORDINANCE – A draft week ordinance was presented to the Board of Supervisors by the Planning Commission Members on June 3, 2017. This draft was reviewed by the Supervisors at the work session with focus on exemption of agricultural areas. A clean draft will be typed up and presented to the Supervisors for review.

RIPARIAN BUFFER ORDINANCE – Our Solicitor, Tom Oeste reviewed the latest riparian buffer ordinance and returned it to the Supervisors with his comments. Comments and questions from the Supervisors are as follows:

OXFORD REGIONAL PLANNING COMMISSION – Will be discussing Woodland Mapping and Historic Preservation. Blair Fleischmann suggested to the Supervisors that we have a representative on this study. Scott

stated that we need to study this and make a decision at our next regular scheduled meeting. Comments can be forwarded to Charlie before the meeting.

PARK PAVILION LIGHTS – Were discussed by the Supervisors. Presently all lights and wires from the sockets have been removed or broken by vandals. At our next meeting we will discuss if it is feasible to replace these items.

FLORID FLIES – A resident sent an email complaining about the trouble they are having in Turners Pond Development with florid flies. Meetings were held in New Garden and Kennett Township which Upper Oxford was not aware of. Scott will reach out to both Townships for more information.
