The meeting was called to order at 7:00 P.M. by the Chairman, Scott Rugen.

MINUTES – Motion was made by Charles Fleischmann, seconded by Howard Reyburn and carried to approve the August 8 2022 regular minutes and the August 22, 2022 work session minutes.

OXFORD REGION PLANNING COMMITTEE – a meeting was held August 24th by a zoom video conference. Items of discussion were as follows:

- Municipal Updates Oxford Borough has been working with the DVRPC
- Warehouses Route 1 Task Force maps have been sent out encouraging development of warehouses in their communities.
- Stormwater Management Plan DEP has not approved the County Plan. Municipalities provided an update on their progress. Supervisor Fleischmann informed the other two supervisors the positions of the other townships.
- Active Shooter Drills the other municipalities had questions regarding the active shooter planning.
- Jennersville Hospital Christiana Care main goal is to get the emergency room reopened. They are still accepting input from the community.
- Chester Co. Planning Complete Streets Policy Supervisor Fleischmann stated that this may not affect us now but maybe in the future. We will pass this along to UOT Planning Commission to discuss.

• ORPC Historic Sub-Committee – they hope to move the grain separator to the agricultural heritage center The next meeting of the ORPC will be September 28, 2022. We will have the UOT Planning Commission review the above and then report back to the ORPC.

UNION FIRE COMPANY AND UNION FIRE CO. AMBULANCE CONTRACT – These will be discussed at our annual budget meeting. Supervisor Rugen will reach out to the Fire Company to see if they would be willing to lower their rates after Christiana Care (previously Jennersville Hospital) opens. Cochranville Fire Company is having a meeting September 29th which Scott will attend.

ZONING – The Zoning Officer showed the Supervisors a video of the State Police making an arrest on Draper Lane. Bill Beers is still checking reports of a resident building in a flood plan and is also checking High Tunnel and Stormwater Plans.

ENGINEER – The Supervisors read the engineer's report for the month.

ROADS – The Supervisors read the road report for the month.

PAYMENT OF BILLS – Motion was made to approve the payment of bills in the amount of \$30,492.41 from the General Fund and the amount of \$52,110.00 from the State Fund.
